2 hours of seminars per week. 28 hours of seminars per semester. In-class format.

Assesment methods:

Student during the semester presents seminar papers. For a written test to obtain evaluation A must achieve at least 90% of the total score. To obtain a evaluation B must achieve at least 85% of the total score. To obtain a evaluation C must achieve at least 80% of the total score. To obtain a evaluation D must reach at least 70% of the total score. To obtain a evaluation E must achieve at least 60% of the total score. Final assessment: exam - weighted arithmetical average, where the seminar work and its presentation has a weight of 1/3, written test has a weight of 2/3. In assessing the seminal work educators may consider other student activities during the semester.

Learning outcomes of the course unit:

A student passing the subject will acquire orientation in the basic concepts of insurance. The student will know the required wealth of theoretical knowledge about insurance. The student will be able to characterize insurance, insurance entities and insurance classification. Following the successful completion of a learning process will be able to do a simple analysis of the specific insurance markets and insurance types and sectors.

- 5. Legislative fundamentals of insurance.
- 6. Risk and insurance.
- 7. Insurance and its optimization.
- 8. Life insurance principles, classification, characterization and analysis.
- 9. Non-life insurance principles, classification, characterization and analysis.
- 10. Liability insurance, insurance of foreign risks, credit insurance.
- 11. Marketing in the insurance industry.
- 12. The insurance market of the EU.
- 13. Presentation of seminar work.
